**2. Minutes of the PRSCO Council Meeting in Bali, 19 June 2002**

The minutes were approved as a correct record of the meeting.

**3. Report on the 2002 Summer Institute, Bali, Indonesia**

B. Resosudarmo gave a brief oral report on the recent PSCRO Summer Institute that was held June 20-21 at the Melia Bali Hotel in Nusa Dua. The Summer Institute attracted 88 participants in total and 79 papers were presented. It was noted that, in line with PRSCO policy to encourage participation of students and scholars from developing countries, the

registration fee was waived for 35 participants. In addition, 11 participants received an accommodation subsidy and 6 participants received a transportation subsidy.

B. Resosudarmo and his Indonesian colleagues were thanked for organizing a very successful meeting. This sentiment was reinforced with acclamation.

#### **4. Report on the 2002 PRSCO Symposium, Sapporo, Japan**

A report prepared by J. Poot had been attached to the agenda for the meeting. J. Poot summarized this report briefly.

#### **5. Report on preparations for the 18<sup>th</sup> PRSCO conference in Acapulco, Mexico, June 30 – July 4, 2003**

On behalf of AMECIDER, R. Wences of the University of the State of Guerrero reported on progress in conference organization. The conference would be held at the Hyatt Regency Acapulco hotel with very attractive room rates, starting at US \$65 (plus tax). A conference brochure was distributed. The conference would be hosted jointly by AMECIDER and the University of the State of Guerrero. Participant would arrive to a welcome reception on June 30, with paper sessions on July 1 to 4. An excursion would also be organized.

#### **6. Discussion of possible venues in Chile for the 2004 Summer Institute**

Dr Ramon Antonio Gutierrez, who was unable to come to Puerto Rico, would be the likely organizer of this Summer Institute. He is also involved in organizing the APEC meeting in Chile in 2004. The dates of the Summer Institute would be decided at the next PRSCO council meeting in Acapulco.

#### **7. Vote on Confirmation of the Venue and LOC of 19<sup>th</sup> PRSCO conference**

Y. Higano provided information on this forthcoming conference. The conference would be held in the Department of Economics, No. 7 Building, Nihon University in Tokyo. The dates are tentatively set for Monday 25 July to Thursday 28 July 2005. The Chairperson of the Local Organizing Committee will be Professor Keiichi Tanaka of Nihon University. Y. Higano provided a list of members of the organizing committee. Sustainability in a broad sense may be the major theme. Sponsorship would be sought from the Science Council of Japan. A formal motion to hold the 19<sup>th</sup> PRSCO conference in Tokyo was proposed by J. Quigley, seconded by R. Stough. The motion was carried unanimously.

#### **8. PRSCO delegate for the RSAI, 2003-2005**

This position is currently held by J. Serrano of AMECIDER. It was suggested that J. Serrano should remain in this position because of he will be the President of PRSCO during 2004 and 2005. A motion to this effect was proposed by K. Haynes, seconded by Y. Higano. The motion was carried unanimously.

#### **9. Progress report on regional science groups in the Pacific Rim area**

B. Resosudarmo mentioned that he had spoken to I. Yussof (PRSCO friend from Malaysia) and Mr Sappuno (PRSCO friend from the Philippines) to see if a future meeting could be held in either country. K. Haynes noted that it would be important to

use the network of RSAI contacts in Malaysia to broaden interest in a meeting there. R. Wences said that the presence of two existing national organization in regional science in South America, in Mexico and in Brazil, would be helpful for establishing further RSAI sections in this part of the world. A meeting in Chile could lead to a new section there, and possibly also in Argentina. In the ensuing discussion, it was noted that there was a misconception in organizations such as the World Bank and the Asian Development Bank that RSAI is just concerned with transportation issues and that this may have hampered access to international funding. The changing organization and policy of RSAI was foreshadowed (see also point 11).

### **10. *Papers in Regional Science***

The Editor-in-Chief, R. Florax, mentioned that there is an encouraging upward trend in the number of submitted manuscripts. It was expected that by next year or so, the average number of manuscripts submitted per year might be about 100. Jessie Poon had been appointed as North American editor in 2002. He also noted that the impact of the journal has been increasing in terms of citations. A special issue to commemorate the 50<sup>th</sup> Anniversary of the RSAI would be launched at the November 2003 meeting of the RSAI in Philadelphia. R. Florax also noted that a change in the organization of RSAI will have an impact on PiRS. Some membership services are likely to be provided by the publisher of the journal.

J. Poot noted that Pacific manuscripts submissions had been increasing this year, although the Pacific is still somewhat underrepresented in the total. Language remains an issue in the Pacific and authors from some countries are encouraged to ask native speakers of English to edit their paper before submission.

### **11. RSAI matters**

K. Donaghy noted that he would retire as Executive Secretary of RSAI at the end of 2002, to be replaced by Dr Graham Clark of the University of Leeds. The Secretariat of RSAI would also shift to the University of Leeds upon the retirement of Beth Carbonneau of the University of Illinois at Urbana-Champaign. It was likely that the organizational structure of RSAI would change and that some member services would be outsourced. A transition committee was formed, chaired by President-Elect A. Bailly. It would report back at the PRSCO conference in Acapulco. One of the main aims of the reforms would be to ensure that all 10,000 members or so of regional science organizations around the world would become part of the RSAI at little cost. It was noted in the discussion that the association may also need to cast a wider net in terms of the represented disciplines.

### **12. Other business**

The next Council meeting would be held in Acapulco in the morning of the 4<sup>th</sup> of July 2003, before the RSAI Council meets in the afternoon of that same day.

D. Plane closed the meeting at 7:00 pm, after which a dinner was held at Italian Restaurant Il Perugino, 105 Cristo Street in Old San Juan.
